RECORD OF VOTES ON THE WEEKS BILL TO CREATE NATIONAL FORESTS

The Weeks bill, a general measure for the acquisition of National Forests and for cooperation with the states in forest protection, which came out of the agitation to protect the Southern Appalachian and White Mountain forests, passed the national House of Representatives March 1, 1909, by a vote of 157 to 147, with 82 members not voting.

The record of the representatives of each state is given in this bulletin.

The Weeks bill in the House is in the hands of the above-named committee, which stands, as the record shows, 8 to 7 in favor of the bill, with three men (Pratt, Hanna, McDermott) unplaced.

The Senate Committee

In the Senate the bill is in charge of the Committee on Forest Reservations and the Protection of Game: Senator Brandegee, Connecticut, *Chairman*; Senators Depew, New York; Perkins, California; Burnham, New Hampshire; Smoot, Utah; Lodge, Massachusetts; Tillman, South Carolina; Overman, North Carolina; Taylor, Tennessee.

This committee is believed to be practically unanimous in favor of the bill.

The bill should pass the House by an increased majority. It must first be got out of the committee.

Make known to your Senators and Representatives your opinion on the bill and urge others to do so. This is a patriotic duty. If your representative voted *yes*, let him know that you approve; if *no*, use what influence you can to show him the importance of the bill and the reasons why he should vote *yes*; if he did not vote, try to stimulate his interest so that he will vote next time. This is your duty, the way in which you can help.
