

REPORT OF THE AMERICAN FORESTRY ASSOCIATION PIONEER TRAIL RIDERS TRIP NO. 1  
IN THE FLATHEAD NATIONAL FOREST, JULY 11-17, 1933, INCLUSIVE.

Personnel of the Trip

Aside from the packing outfit, there were 22 individuals to make the trip. There were seven more in the packing outfit making a complete party of 29, with 55 head of stock. The individuals who went as guests were.

Mr. Alderton is a professor at Chicago University and his wife teaches in High School in Minneapolis, commuting on week ends.
