IT HOUSES OVER 200,000 HISTORIC PHOTOGRAPHS, 12,000 BOOKS, MAPS, MOVING FOOTAGE, ARTWORK, AND OVER 350 ORAL HISTORY INTERVIEWS. IT PROVIDES FREE ONLINE DATABASES FOR REMOTE RESEARCHING FOR K-12 AND COLLEGE STUDENTS, TEACHERS, JOURNALISTS AND OTHER RESEARCHERS. OVER 5,000 SEARCHES ANNUALLY ARE CONDUCTED IN THE DATABASES AND OVER 100,000 USERS REACH FHS WEB PAGES FOR INFORMATION. THE ARCHIVES PRESERVE ALMOST ONE-MILE OF UNIQUE RECORDS FROM INDIVIDUALS, FAMILIES, COMPANIES, AND INSTITUTIONS AND HOSTS ON-SITE RESEARCHERS FROM AROUND THE WORLD.
